SERVICE TO THE COMMUNITY

1. Poverty eradication, community development and preservation of South Asian arts and culture:

I have been involved with the Hindu Community Center (Lenoir City) with food assistance and other charity work. I donate clothes and other household items to the local KARM store. As a first-generation immigrant from India, South Asia, I had my own share of immigrant' experiences that has shaped my assimilation and integration in the East Tennessee region. I am an avid supporter of South Asian Arts and Culture, and one of the various ways I do this is by attending the semi-annual concerts organized by the Knoxville Indian Classical Music Group (KICMG). It is also involved in providing free healthcare benefits to the community in East Tennessee that goes beyond covering South Asians. In the past several years, the KICMG in coordination with the HCC has been involved in providing Covid-19 vaccines, and free health check-ups (dental, vision, and physical exam) to people who so desire. A significantly large share of membership of KICMG comprise of highly specialized doctors and specialists, scientists, university faculty and successful businessmen—all of which are critical toward supporting these social welfare activities.

2. Participative approaches to grassroots development and community building: I donate money to an urban village-based English medium elementary school in a primitive urban/rural township in Purulia district, one of the poorest and remotest districts in the State of West Bengal. This school was started by a retired schoolteacher from my secondary school (my English teacher) who sold her jewelry to buy a small building to run this school. The school's name is *BDM Rising Sun School*. This school provides free education and teaching material like school uniforms, mid-day meals, textbooks, notebooks and other educational material to the poor children of domestic maid servants and other poorer segments in the slums of this township. Games & sports and cultural activities are also practiced. These facilities do not exist elsewhere in Purulia town, and where they exist, those schools charge very high. My annual donation sponsors a girl child's education in this school.

3. Sustainable approaches to socio-economic equality and justice: My life-long motivation is to strive for socio-economic justice for vulnerable population groups. This started during my professional work experience at grassroots level with rural/tribal development and poverty eradication programs run by the government, non-profit, and international development agencies in India. Later these were translated into academic work by my engagement in mixed-methods approaches to empirically advance the theories of socio-economic equity and justice for groups categories along race/ethnicity, gender, nationality, and much more.
